- **VENDORS RECEIVE DIRECTORY LISTING IN EVENT PROGRAM**
- **ALL VENDORS RECEIVE THEIR LOAD-IN/OUT PACKAGE AT THE VENDOR CHECK-IN GATE. ENTER AT MAIN GATE FOR DIRECTIONS. VENDOR SET-UP INFO WILL ALSO BE EMAILED NO LATER THAN ONE WEEK PRIOR TO THE EVENT.**
- Vendor set up: Fri. 6/10 – 9am-6pm, Sat. 6/11 –8am to 1pm ~ No vehicles allowed after these times per AV Fairgrounds regulations and all vehicles must be removed from the event location and park in Vendor Lot.
- All “selling” vendors must provide their sellers permit number.
- **NOT PROVIDED: TABLES, CHAIRS, EXT. CORDS, TAPE, TIE-UPS, EZ-UP'S OR TOOLS**
- **NO MOTORIZED VEHICLES ARE PERMITTED OUTSIDE OF THE VENDOR BOOTH SPACE-YOU RISK BEING REMOVED FROM EVENT. DISPLAY VEHICLES MUST STAY PARKED IN BOOTH!!!**
